Episode - 1

Episode - 2

The owner of the mills, Chowdary is called in. he is shown the rice with stones. He is asked how much do they give the D.S.P. he stammers and doesn't answer. He requests the S.I. to permit him to take away confiscated rice bags.

Choudary gives a long list of officials who indulge in receiving bribes. The warden goes to see if a telephone is around so that Chowdary can speak to the minister.

The thief who ran across the area in the beginning comes again and enquires whether any woman committed suicide here. And she has three children. He goes hurriedly to see the dead bodies.
